

A Scout's Dishonor : Boy Scouts of America's Moral Bankruptcy!

Summary

The Boy Scouts of America (BSA), an organization that prides itself on teaching ethical choices and honor code to its over 2.2 million youth members, has filed for bankruptcy court facing over 1700 abuse lawsuits.

The decision to file for bankruptcy has gained harsh criticism from the public, while BSA claims this decision benefits the victims of the claimed abuses.

This case study examines the BSA's handling of the abuse claims and its decisions to file for bankruptcy. We will discuss the ethical ways for BSA to handle the abuse claims as well as what consequences BSA should have.

Timeline

2017

Lobbies against “Child Victims Act” – legislation that would make it easier for child sex abuse victims to seek justice as adults.

2019

Statue of limitation changes. Survivors of childhood sexual assault will have more time to report abuse allegations and file lawsuits

2020

With thousands of lawsuits against them for child sexual abuse, the Boy Scouts of America filed for Chapter 11 bankruptcy, listing assets up to \$10 billion.

- Estimated assets of more than \$1 billion
- Local councils are legally independent, separate and distinct from the national organization.
- No local council assets are directly affected by the Chapter 11 filing because the local councils are not filing entities.



- ***What is chapter 11 bankruptcy?***

A chapter 11 debtor usually proposes a plan of reorganization to keep its business alive and pay creditors over time.

- ***What does chapter 11 means for BSA abuse survivors?***

1. the Chapter 11 bankruptcy process means that the bankruptcy court will set a deadline for filing claims, approximately 6 months or so. This deadline severely limits Scouting abuse survivors' time to file claims for their abuse.
1. The bankruptcy filing means that to reach a settlement with the thousands of Scouting abuse survivors across the U.S., individual survivors will not get their day in court. However, the streamlined nature of settlement process may mean abuse survivors will get the compensation they deserve more quickly and efficiently than having future individual trial dates.

Jim Turley (national chairman) : “ Boy Scouts were not trying to dodge responsibility for compensating them. Instead, he said, the organization wanted to do so as equitably as possible through a victim’s compensation trust.”



BSA website : BSA has a social and moral responsibility to equitably compensate all victims who were abused during their time in Scouting. We also have a duty to carry out our mission for years to come.

Scouting is safer now than ever before. Approximately 90% of pending and asserted abuse claims against the BSA relate to abuse that occurred more than 30 years ago.

To the victims : I want you to know that we believe you, we believe in compensating you, and we have programs in place to pay for counseling for you and your family by a provider of your choice.



Compliance

- 12,000 boys were molested by around 7,800 abusers.
- Screening and referencing practices ----failing to protect the youths from abusers
- Youth protection policies

A ban on one-on-one contact between adults and youth – in person, online, or via text.

Prompt mandatory reporting to law enforcement of any allegation or suspicion of abuse.

- Maintaining Institutional Secrecy (Perversion Files)

- Better communication between national body and local chapters

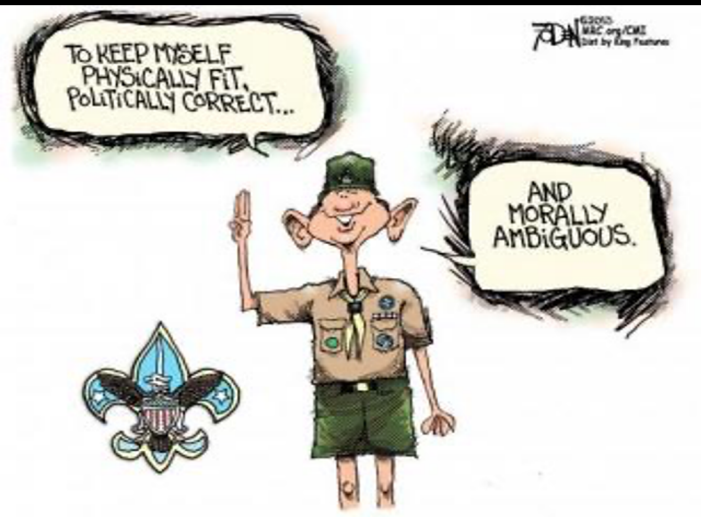

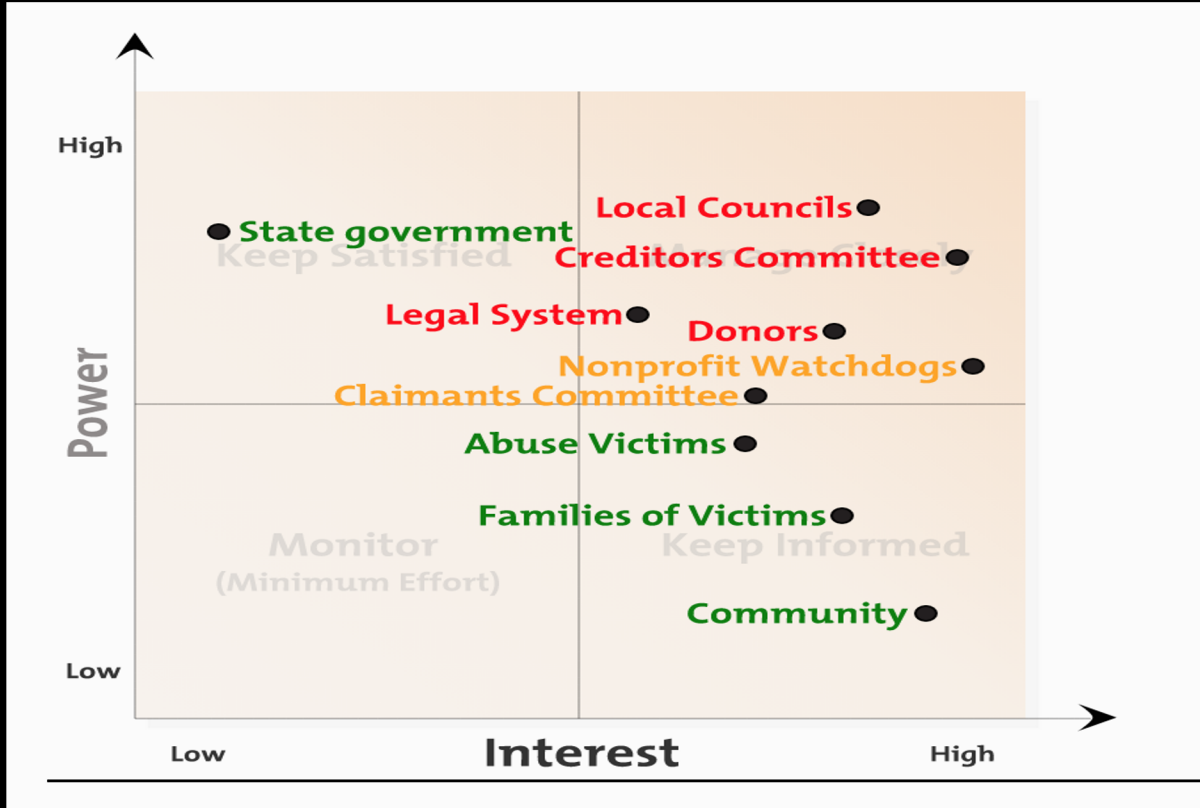
Systemic Responsibility
